



### COVID VACCINATION

People with disability have been determined by the WHO to be particularly vulnerable to the effects of Covid. As an organisation bringing programs to Tasmanians with disability, our new vaccination policy aligns with our duty of care. From Term 1 2022, for an initial 6-month period, New Horizons Tasmania (NHT) will require the following people to be fully vaccinated against Covid-19 (in line with Tasmanian Public Health Requirements):

- All active members, who attend programs at any of our venues or partner venues
- Anyone attending programs with members (support workers, family members etc) at any of our venues or partner venues
- Anyone attending any NHT social occasion or gathering (Awards Night, Dinner Club etc) and anyone attending with them.
- Anyone attending / visiting the NHT clubhouse and office at 292-294 Invermay Rd, Mowbray or the NHT Hobart office at Blundstone Arena, Hobart, for any reason.

**All NHT staff and active volunteers (coaches, assistants, drivers etc) will also meet these obligations.**

Membership will not commence until confirmation of Board approval, receipt of a copy of the organisations Public Liability Insurance Certificate of Currency and payment of membership fee.
5. Organisations/Schools will be required to supply a list of participants who will be accessing our activities including basic details – a form for this will be provided.
